Attachment A

Scope of Work

- A. Consult with the Agency physicians on use of psychotropic medications.
- B. Consult with Drug Monitoring Teams on clinical drug reviews for each person served.
- C. Provide direct evaluation and treatment to persons served where deemed appropriate by the provider in conjunction with the respective Habilitation Teams.
- D. Assist with the transfer of persons served to and from a short-term care facility.
- E. Designated start time for psychiatric clinics will be determined by the respective psychiatrist and Director of Psychological Services or designee appointed by Agency Director.
- F. Provide documented observation of the persons served participating in programmatic activities and the documented review of behavioral and psychometric data provided, with recommendations as appropriate.
- G. Orders issued will be verified in TIER within thirty (30) calendar days.
- H. Designated programmatic contract for Ellisville State School will be, Director of Psychological Services or Designee appointed by Agency Director.
- I. Consult with Agency Medication/Pharmacy Review Board if deemed necessary by the Agency.
- J. Other duties as deemed appropriate for a Psychiatrist. Psychiatrist will need to provide a schedule at least one (1) month in advance and any changes in the schedule must have prior approval of the Agency Director and Director of Psychological Services or Designee appointed by the Agency Director.
- K. The Community Contract Psychiatrist Provider will assist in the management of on-call needs for campus. However, the hired Contract Psychiatrist shall have up to one (1) hour of on-call per month.
- L. The Contractor or designee will arrange with the Agency personnel as to which days shall be the visit days and what persons served are to be evaluated.
- M. The Contractor may visit the Agency an unlimited number of times per month, but shall not exceed twenty (20) hours per month, excluding travel.
